
Let's get down to business

The BID ballot – how to vote

Ballot papers will be issued to all businesses located in the BID boundary from 21 September 2021. Voting closes at 5.00pm on 21 October 2021.

There are a few ways you can submit your vote:

- 1. Seal your ballot paper into the envelope provided and post at any Royal Mail mailbox.
- 2. Walk to our ballot box at Peterborough Town Hall on Bridge Street and post your vote there (if the building is closed your vote may be posted through the letterbox where it will be collected and transferred to the ballot box).
- 3. We can visit your premises to collect your vote and courier it to the Town Hall ballot box. To arrange collection, please email us at contact@peterboroughpositive.co.uk or phone 07951 942995.
